We, the representatives of the Crimean Tatar public, are writing to you in order to initiate the nomination, for the 2011 Nobel Peace Prize, of Mustafa Dzhemilev: well-known human rights defender, Chairman of the Mejlis of the Crimean Tatar People, and Deputy of the Verkhovna Rada of Ukraine since 1998 (III, IV, V, VI convocations).
